- A. CALL TO ORDER:** The LPW Meeting was called to order at 7:05 pm by Jim in Donna's absence.

- C. FOOTBALL DIRECTOR:** Total to date of 135 football players. Coaches meeting went well. Weigh-ins to be held August 23rd and Jamboree in Oakmont, August 24th.
- D. CHEER DIRECTOR:** Total of 54 cheerleaders signed up. More coming in. Cheer Coaches clinic coming up next weekend and one in August. Uniform fitting July 17th at Southeast. Missing quite a few body liners from last year.
